1 The OHMI Trust shall let and the Renter shall hire: A **left/right* handed** instrument and/or apparatus.

*** 'Claritie' valued at £59 Descant recorder valued £530**

Trumpet/Cornet AND stand valued at £230 Tuba Stand valued at £120

Trombone Stand valued at £120 Baritone stand valued at £120 LinnStrument 128 valued at £1000

Trumpet/cornet STAND ONLY valued at £100 Chapman Stick valued at £3000

One handed flute valued at £6000 Artiphon valued at £400*

2 The Renter agrees to pay The OHMI Trust the sum of one year rental charge as a refundable deposit plus the annual rental charge. This annual rental charge will be payable at the same time each year until termination of this Agreement. The deposit will be returned on safe return of the instrument and/or apparatus.

3 a) The Renter may terminate this Agreement at the end of the first yearly period or any subsequent yearly period by giving written notice, paying any rentals due and by delivering up, at the Renter's cost the Instrument and/or apparatus to The OHMI Trust within 7 days of the end of said yearly rental period. The Instrument and/or apparatus will remain the responsibility of the Renter until The OHMI Trust receives it.

4 The Instrument and/or apparatus remains the property of The OHMI Trust during the Hire Period and the Renter shall not sell or offer for sale, assign, mortgage, pledge, under let, lend or otherwise deal with or part with the possession of the Instrument and/or apparatus.

5 The OHMI Trust will insure the Instrument and/or apparatus. The Renter will take reasonable care of the Instrument and/or apparatus and will be liable for loss of or damage to the Instrument and/or apparatus caused by ill-use or negligence

6 The Renter shall not allow any person to carry out any work on the Instrument and/or apparatus without permission in writing from The OHMI Trust.

7 Neither termination of this Agreement (for whatever reasons) nor any relaxation or indulgence afforded to the Renter shall affect the right of The OHMI Trust to recover damages in respect of breach by the Renter of the terms of this Agreement.
